- I. Call to Order –
Mayor Lutitia Ford called the regular meeting of the Bryson City Council to order at 7:00 pm on February 14, 2023, in City Hall.

- IV. Guests Deborah Milburn and Jake McAdams introduced themselves as bidders for the City's 2022 grant and gave council opportunity to ask questions.
- V. Motion was made to approve consent agenda including all bills as presented and minutes for the February 14, 2023, Regular Meeting by Ald. Shelly Tinney; seconded by Ald. Heather Neer. Vote 5-0
- VI. Motion was made to award the bid for grant administrator to Grant Works by Ald. Ray Jennings. Motion died due to lack of second. After more discussion and Public Management offered to reduce their bid price from \$25,000 to \$24,000 (\$500 less than Grant Works) motion was made to accept Public Management bid by Ald. Larry Nantz; seconded by Ald. JR Stearns. Vote 5-0
- VII. Motion was made to approve TML Benefit Waiting Period to reflect a 30 day waiting period after the first day of the month following employment date unless an employee starts on the first day of the month then 30 days from that day by Ald. Ray Jennings; seconded by Ald. JR Stearns. Vote 5-0
- VIII. Motion was made to approve the call for the May 6, 2023 General Election for Mayor and two Aldermen by Shelly Tinney; seconded by Ald. Heather Neer. Vote 5-0
- IX. Discussion was made regarding baseball field maintenance bids. PWD can move forward with selection of person to maintain fields and to terminate the use of Jasen's Lawn Service.
- X. Discussion regarding mural on the City Hall wall; working on other options at this time.
