

# City of Bryson Council Meeting

- I. **Call to Order:** Mayor Lutitia Ford called the regular meeting of the Bryson City Council to order at 7:00 pm September 9, 2024, in City Hall.

- VIII. A motion was made to approve the rate for bulk untreated water of \$7 per 1,000 gallons by Ald. Jesse Laine; seconded by Ald. Shelly Tinney. Vote 4-0
- IX. After discussion, a motion was made to set the 2024 Fall Clean-Up for October 4 and 5 by Ald. Jesse Laine, seconded by Ald. Travis Rhoten. Vote 4-0.
- X. Discussion was made on two maturing CDs from First State Bank. The item was postponed to next month's regular meeting.
- XI. Motion was made to approve the FY 2024-25 Budget by Ald. Travis Rhoten; seconded by Ald. JR Stearns. Vote 4-0.
